

WHAT IS FAMILY VIOLENCE?

Family violence occurs between family members and/or people who live together or used to live together such as spouses, ex-spouses, boyfriends, girlfriends, same-sex partners and roommates. The violence is often physical, but may also be in the form of threats, isolation, emotional mistreatment or forced sexual activity.

IF YOU ARE A VICTIM OR SURVIVOR OF FAMILY VIOLENCE:

- ◆ **YOU ARE NOT TO BLAME.** Only the batterer is responsible for using violence.
- ◆ **YOU HAVE THE RIGHT** to a safe and healthy relationship.
- ◆ **YOU DESERVE** to be treated with respect.
- ◆ **YOU ARE NOT ALONE.** 1 out of 4 women is abused by a loved one. Violence crosses all cultural, ethnic, racial and economic lines.
- ◆ **REACH OUT.** Support is available to you.

WHAT IS THE FAMILY VIOLENCE PROTECTION TEAM?

The Family Violence Protection Team is a collaborative, community response to family violence that provides multiple services at one location. We improve access to law enforcement, counseling, crisis management and legal services for survivors of family violence and their children. We hope to increase batterer accountability, empower survivors to lead violence-free lives and lead the community's zero-tolerance on family violence.

WHAT SERVICES ARE PROVIDED AT THE FAMILY VIOLENCE PROTECTION TEAM?

INVESTIGATIVE SERVICES

- ◆ Detectives investigate cases and issue warrants for the arrest of suspected batterers.
- ◆ Detectives take statements from victims, witnesses and suspects.
- ◆ Detectives take photos of visible injuries for evidence.

LEGAL SERVICES

- ◆ Attorneys help get emergency protective orders for survivors of family violence.
- ◆ Legal assistants and attorneys help family violence survivors obtain long-term protective orders.
- ◆ Legal assistants help link survivors to other legal resources that can help with divorce and child custody.

SOCIAL SERVICES

- ◆ Counselors provide crisis, short-term and on-going counseling to survivors of family violence.
- ◆ Children who witness violence in the home receive therapy.
- ◆ Counselors assist in safety planning, court advocacy, and case management.
- ◆ Assistance is also available to apply for Crime Victims' Compensation.
