

WORDS FROM THE SHERIFF



Phone scams are a prevalent and sinister use of modern technology. On a cyclical basis, for the last several years, scammers have used the actual names and ranks of TCSO deputies to scare people into giving them money.

The most common scam is the jury duty scam. Scammers spoof a TCSO phone number, so the call appears legitimate on caller ID. The scammer uses aggression and intimidation, claiming the resident has failed to report for jury duty and must pay a fine immediately to void a warrant that has been issued for their arrest. The scammer might also pose as a local judge as a scare tactic to "set-

Victims have also reported receiving calls from a caller ID that comes up as "Travis County Jail." The scammer states that the person's son or daughter caused a car crash and is now in jail needing to be bailed out. In some instances, the scammer has even posed as the son/daughter in jail.

tle" civil proceedings.

In every instance, the caller seeks immediate payment via gift card or MoneyPak. The scammer will often stay on the phone with the resident while they purchase the cards. They ask the resident to read the code on the back of the card and immediately receive the funds.


TCSO will never seek payment for anything via wire transfer, gift cards or MoneyPak!

Although the scammer's caller ID says the call is coming from TCSO, the number is actually being spoofed. The scammers are most often calling from outside the United States. TCSO receives reports regarding the scams and cooperates with Federal investigators.

If you receive a call from someone claiming to be with our agency or other local agencies demanding immediate payment, especially by gift cards or MoneyPak, hang up.


Scammers target senior citizens and are often successful in confusing or scaring them. Please make sure your elderly loved ones are aware of the scams.
